

## Fluke Australia x TradeMutt Lottery Terms & Conditions

**1. Lottery Description:** Eligible customers in Australia or New Zealand (as defined in 'Section 2') who participate in the 'Fluke Australia x TradeMutt Lottery' during the Entry Period (as defined in 'Section 3') and meet all requirements as set forth in these terms and conditions are eligible to enter a random selection lottery to receive one (1) chance to win one (1) Fluke Australia x TradeMutt 2025 Limited Edition 'More than Luck' High-Vis Work Shirt.

**2. Eligibility:** The lottery is open to legal residents of Australia or New Zealand who are over age 18. Void wherever else prohibited by law.
